Dear Member:

As we previously advised you, employees can no longer deduct union dues from their federal taxes in tax years 2019 through 2025 as a result of the Tax Cuts and Jobs Act (TCJA) that Congress signed into law on December 22, 2017.

While union dues for employees can no longer be deducted from your federal taxes, you may, depending on your own circumstances, still be able to deduct the dues and working assessments on your Pennsylvania tax returns on Schedule UE, Unreimbursed Business Expenses. Unreimbursed business expenses, such as union dues and working assessments are not deductible in New Jersey.

Because each member's situation may be different, you must consult with your Tax Adviser if you have any questions about the deductibility of your union dues or working assessments.

Working Assessments for Building Trades Journeymen, Mechanical Equipment Service (MESS and MESJ), Gas Distribution Journeymen and Gas Distribution Helpers are as follows:

(Hourly wage + Health & Welfare + Pension + SRP + Apprentice Training Fund) x 1 ½% = Rate per hour
